I.C. 35-42-2-5.3(a)(3)

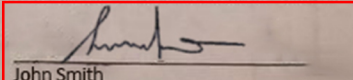

COUNT III - BATTERY (CLASS B MISDEMEANOR)

On or about November 9, 2025 in Clark County, State of Indiana, Timothy J. Wissman did knowingly or intentionally touch Karen R. Miller in a rude, insolent, or angry manner.

I.C. 35-42-2-1.3(a)(1)

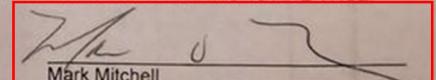
